# **Position Summary**

This position is a one-year structured postgraduate education and training program. The goal of the program is to provide the resident with advanced knowledge and skill set related to drug therapy and pharmaceutical services in a managed care setting. To meet these goals, the resident rotates through different PSPH subdepartments to cover topics including but not limited to administration and contracting, clinical data extraction, clinical program development, pharmacy operations, disease state management, and medication use management. Activities, projects, and responsibilities are specific to each learning experience.

### Responsibilities

- Achieve goals and objectives of the required learning experiences.
- Complete year-long resident project and present results at the Western States Pharmacy Residency Conference.
- Attend two pharmacy conferences including ASHP Midyear Clinical Meeting.
- Manage residency program recruitment, applicant selection and interview process.

- Participate in APPE program management and precept APPE students.
- · Attend internal committee meetings with the Residency Director and preceptors.
- Conduct clinical data extraction analyses to identify areas with large practice variation, gaps in care, or opportunities to improve quality in HPMG network.
- Develop clinical initiatives to impact physician behavior

- Letter of interest describing why the applicant has chosen to complete a managed care pharmacy practice residency and why he/she is specifically interested in the residency at Hill Physicians Medical Group
- Letter of recommendation from three faculty members or work supervisors (at least 2 must be familiar with the applicant's clerkship performance)
- An official transcript of all course work completed in the professional pharmacy curriculum
